OBLIGATIONS OF FREIGHT SALES AGENT

- 1. FREIGHT SALES AGENT agrees to locate freight, freight bids & contracts on behalf of the BTN for BTN's REPRESENTED CARRIERS. FREIGHT SALES AGENT will represent BTN, in BTN's represented carriers name for this purpose only. FREIGHT SALES AGENT shall handle leads, phone & fax calls to and from the SHIPPER to tender commodities shipments to BTN's REPRESENTED CARRIERS for transportation in interstate commerce by BTN's REPRESENTED CARRIERS.
- 2. FREIGHT SALES AGENT shall bear no financial or legal responsibility in the transaction between the REPRESENTED CARRIERS & BTN agreement except where in FREIGHT SALES AGENT is found to be in violation of paragraphs 1 3,4,5 & 6.
- 3. FREIGHT SALES AGENT shall direct all paperwork, necessary of signature, to BTN, REPRESENTED CARRIERS AUTHORIZED AGENT, for approval and completion, unless otherwise directed in writing by the REPRESENTED CARRIER.
- 4. FREIGHT SALES AGENT shall not purposely or with intent, agree to or accept or bind freight quotes, bids, contracts, or offerings, nor will they accept loads or different than preferred pricing of load without the consent of the BTN's REPRESENTED CARRIERS.
- 5. FREIGHT SALES AGENT shall not, in good faith, offer favors or kickbacks to SHIPPERS to obtain either freight or good paying loads, or both. FREIGHT SALES AGENT will not, in good faith, knowingly accept loads that have been double brokered by the Load Offering Party. FREIGHT SALES AGENT will not accept payment of services directly from the SHIPPER.
- 6. FREIGHT SALES AGENT shall not bind or charge BTN for any office or marketing expense incurred by the FREIGHT SALES AGENT. This includes, but is not limited to, sales lead charges, advertising, phone bills, online services, load boards (except at the request of BTN for additional load boards), office supplies, travel (unless BTN Specifically requests FREIGHT SALES AGENT to travel on BTN's behalf), vehicle, or any such like.

- 7. FREIGHT SALES AGENT is an independent contractor and is not an employee of BTN. FREIGHT SALES AGENT is responsible for all expenses it incurs, except for things provided by BTN in contract.
- 8. FREIGHT SALES AGENT shall hold BTN harmless from any liability for personal injury or property damage occurring as result of neglect or misrepresentation caused by the FREIGHT SALES AGENT. This also covers violations committed by FREIGHT SALES AGENT pursuant to this agreement in paragraphs 1, 3, 4 5, & 6.
- 9. FREIGHT SALES AGENT shall not bind BTN in a contract or agreement without the consent of BTN or without BTN's knowledge. All commitments, contracts, & agreements must be requested by the FREIGHT SALES AGENT, in writing, before such commitment can be acted upon.
- 10. FREIGHT SALES AGENT shall not be limited to mile radius for locating freight on behalf of REPRESENTED CARRIERS. FREIGHT SALES AGENT shall be grant account protection for any account brought to the agents for the life of the business.
- 11. FREIGHT SALES AGENT shall not be bound in an exclusive limited contract with BTN and is able to contract services out to other carrier's, however, FREIGHT SALES AGENT shall not be able to contract with any of BTN REPRESENTED CARRIERS during the period of BTN's agreement with the REPRESENTED CARRIER. If FREIGHT SALES AGENT works in a non-exclusive role with BTN, FREIGHT SALES AGENT must find at least one (1) load for BTN's REPRESENTED CARRIERS during a 90-day period to keep this agreement active. If no load is move within any three-month period, the FREIGHT SALES AGENT is deemed inactive and this agreement is automatically null and void. FREIGHT SALES AGENT will have to sign new agreement to return to active status.

OBLIGATIONS OF BTN

- 1. BTN shall pay FREIGHT SALES AGENT <u>25%</u> for each load secured by a truck from a customer that the FREIGHT SALES AGENT brought to the company. If FREIGHT SALES AGENT recruits a carrier to the BTN, FREIGHT SALES AGENT shall be paid <u>25%</u> for each load booked through BTN and moved by such carrier. If load is brokered through one of the brokerages above, FREIGHT SALES AGENT shall receive <u>25%</u> of the gross commission. FREIGHT SALES AGENT has ability to earn income from 3 different sources.
- 2. BTN shall provide FREIGHT SALES AGENT with BTN marketing materials and will also provide marketing materials from the REPRESENTED CARRIERS, if available.
- 3. BTN shall be responsible to make sure the credit check is completed on each load moved.
- 4. BTN shall hold FREIGHT SALES AGENT harmless from any liability for personal injury or property damage occurring during operation conducted by BTN pursuant to this agreement.
- 5. BTN shall be responsible to comply with all applicable state and federal regulations pertaining to the operation of a legal company in the United States.
- 6. BTN shall not turn down a load and then contact the SHIPPER or BROKER to accept the same load in question, to avoid paying the FREIGHT SALES AGENT fee to the FREIGHT SALES AGENT.
- 7. BTN shall provide FREIGHT SALES AGENT with leads, sales quote requests, and actual customers, when available to work at no cost to FREIGHT SALES AGENT. BTN shall also assist in sales calls on behalf of

FREIGHT SALES AGENT, if needed. BTN is not responsible for the outcome of the call but will exert full effort to help in obtaining customers.

- 8. BTN's REPRESENTED CARRIERS shall offer FREIGHT SALES AGENT access to Internet load boards for sole purpose of rating freight posting available loads for quotes and load searching for rate comparisons. BTN shall not be responsible for any load board that is obtained for a fee, by the FREIGHT SALES AGENT, other than the access provided by BTN.
- 9. BTN shall pay FREIGHT SALES AGENT for the length term of any contract won during the contact and will pay out until the contract end if the agreement is terminated by the BTN. If the FREIGHT SALES AGENT terminates the contract, the BTN is not bound to the terms of the agreement with respect to full payout for any contract in place at time of termination by FREIGHT AGENT.
- 10. BTN shall notify FREIGHT SALES AGENT, in writing, if REPRESENTED CARRIER fails to pay commission for a load. Any chargeback of commission is from the REPRESENTED CARRIERS and it is the FREIGHT SALES AGENT will be responsible to address this directly with the REPRESENTED CARRIERS
- 11. This agreement shall be deemed to be effective on the first date that BTN, FREIGHT SALES AGENT, and SHIPPER commence business together, and the parties hereby agree that the provisions herein properly express and memorialize the complete understanding as contained in any prior agreement either written or verbal. The terms of this agreement shall be perpetual, provided that either party may terminate same by giving 30 days' written notice to the other.
