



## Census Bureau Return Program

A Box Truck Network customer has been awarded a contract to recover laptops, iPads, and iPhones from various offices across the United States. This work will start on September 14<sup>th</sup>, 2020 and we will service over 250 locations nationwide. The placements will occur immediately upon confirmation of pricing and providing contact information for coordinating dispatch.

### Requirements

1. Scan each device with driver smart device using a mobile app provided by customer in advance of driver arriving
2. Place each device in a gaylord container provided by Census Bureau
3. Stretch wrap the gaylord
4. Transmit data to customer
5. Return gaylord(s) to carrier facility for LTL pickup arranged by customer

Each pickup will require between 100-500 items to be scanned, loaded in gaylord(s) and returned to your facility or you take it to LTL facility chosen by USCB

UPDATED INFO: We want to make this work out for our carrier members. Where it is possible, we will bundle up locations for one truck. The USCB wanted to keep it separately, but this may not be feasible. The PRICING ABOVE IS PER STOP. SO There is a potential to make up to \$1260 in one are with just 2 stops. Our team will make it as smooth as possible. There is a schedule of dates and locations that will be provided to the TIER 1 & Tier 2 Carrier



### Next Steps:

There is two tiers of carriers. Tier 1 is the primary carrier and Tier 2 is the backup carrier. Both Tier Carriers are required to put down deposits of good faith due to the type of cargo being transport. The carriers must make BTN a certificate holder before hauling the first load

**DEPOSIT:** \$250 per Carrier. (If you can't afford to put down a deposit, please don't apply) You can make the deposit payment by calling Philip at 309.264.1175 or Willona at 682.317.3181

**This deposit is just that, a deposit which will be returned to you after the project is over.** BTN may credit the carriers account with the deposit after the project is over, or may refund it. This will be discussed and agreed upon with the carrier at the end of the project. Once the USCB gives the all clear sign (meaning no issues caused by our carrier), the refund or credit will be processed. Any Refund will occur within 30 days of the end of the project. If you put a deposit down and did not get selected, you will get the deposit back within 14 days along with a letter stating the outcome of the selection process. The selection process can take up to 7-10 days to approve the carrier.

We have switched from having our member prepay for 4 months to a deposit due to the responsibilities of this project to the Government. If you want to be considered for a spot should Tier 1 or Tier 2 open, let us know and we will hold the deposit until confirmed that there is no spot. These spots will go fast! We will verify that you are an active member of the BTN and will reach out to you if you are not. **Background Check:** During this time, you will receive a background check form which we will run. If you already had one with us within the last 3 months, you will not have to have one done again.

After you have paid the deposit and signed this agreement, we will send a spreadsheet containing the locations and addresses of the pickup locations. Pickups will be scheduled **every two weeks** through the end of 2020 or unless inventory is depleted prior to then. Identify locations you can support and indicate acceptance of pricing by signing and returning this document to:
